Meisel provided an overview of the recommended Fiscal Year 2020/2021 Annual Operating Budget and thanked the Budget Team for all its efforts with the preparation of the budget, as well as the Broadcast Specialist for producing the budget presentation. He added it was a balanced budget, no tax increases or new debt, and explained there was a pause initiated on employee merit increases, however the City budgeted for a 2.3% cost-of-living increase. It was additionally said the budget would be monitored closely and adjusted as necessary due to the COVID-19 pandemic. There were some questions asked by Commissioner Beasley-Brown related to sidewalks and greenways, workforce diversity, response due to the COVID-19 and CARES Act availability, additional hiring of police officers, and improvements to the 911 center. Once discussion concluded, Mayor Wilkerson asked for additional discussion, and with none, a roll call vote was taken.
