- Accomplishing all of these things within the framework of an open representative government.


Hopefully we have met your expectations and invite you to review what your city government has done over the last year or so to fulfill these goals.



2012: The Year in Review and a Look Ahead

ROADS AND TRANSPORTATION: BETTER WAYS TO GET AROUND TOWN

- Funding and support was provided for the operation of the GO bg Transit System.
- The Old Morgantown Road Project was completed and came in \$800,000 under budget.



- Completed 27 high priority drainage projects through structure repair, curb replacement, sidewalk repairs and altering existing drainage structures.
- Completed the South Park and Covington Street drainage projects which will greatly decrease stormwater issues in those areas.
- 12th Avenue was paved from Chestnut Street to Park Street.


STRONG NEIGHBORHOODS: IMPROVING INFRASTRUCTURE, EMPOWERING PEOPLE

- Assisted eight households with energy efficiency improvements.
- Neighborhood and Community Services (NCS) hired an International Communities Liaison to provide outreach and communication to the international population.



- Sidewalk and stormwater improvements were completed along Boatlanding Road with Community Development Block Grant (CDBG) funds.
- Partnered with Habitat for Humanity to coordinate volunteers for the Code Offense Volunteer Eligible Repair (COVER) program and assisted three households with repair of exterior code deficiencies.





DOWNTOWN REDEVELOPMENT/RIVERFRONT

- Management of Circus Square, Riverfront and Fountain Square Parks was taken over by City staff.
- Analyzed and presented the Block 6 Wrap Development Agreement to the Board of Commissioners and was approved.
- Multiple sidewalk repairs were completed on State Street, Chestnut Street, East Main Avenue and other downtown streets.
- Whiskey Run Storm Sewer was restored between Chestnut Street and State Street.



PUBLIC SAFETY: MORE STAFF, BETTER EQUIPMENT

- Added memory to all the Mobile Data Computers (MDC) to assist with speed after upgrading to Office 2010 and a new Document Management client.
- Bowling Green Fire Department (BGFD) Burn Building was refurbished.

- Upgraded Plymovent Exhaust system in all fire stations.
- Implemented new evidence barcode system within the Police Department.
- The audio visual system in the criminal investigation interview rooms were networked to allow for viewing of live and archived interviews.



- Conducted 23,252 hours of fire training 193.16 hours per person.
- Phase I of the digital forensics lab and equipment was completed which included defining the physical space for the lab and the purchase of hardware and software.
- 17 police officers were hired and trained.
- Six firefighters were hired and trained.



• Purchased a new air lift bag system for Rescue 6 truck, new extrication equipment for Engine 1 and a new breathing air compressor and fill station for BGFD.



PARKS AND RECREATION: NEW AND IMPROVED FACILITIES

- The lighting system at Pedigo Park was upgraded with CDBG funds.
- Parker Bennett Community Center improvement projects are ongoing with the roof repairs and shelter completed. The playground addition, landscaping, court sealing and fencing still remain.
- Lockers were installed and a storage building was built at Russell Sims Aquatic Center.
- Parks and Recreation received record participation of 1,195,902 visits (a 5% increase).



- Rounds of golf played increased at all three courses despite Paul Walker being closed the last month of the fiscal year for greens renovations.
- Overall revenues for Parks and Recreation increased 6%, or approximately \$2.7 million.



• Cardiovascular and selectorized equipment was replaced at the Parks and Recreation Fitness Facility.

WAYS WE'RE SAVING MONEY


- Removed dependence on several Novell products including network login, which resulted in overall cost savings and less overhead.
- Finalized Kentucky League of Cities Insurance Services (KLCIS) endorsement reimbursement for auto and property schedules which returned over \$50,000 in excess premiums and is projected to save \$30,000 annually.




- Refinanced \$7,720,000 of the 2004A & 2004B G.O. Bonds which will save the City approximately \$809,000 over 12 years.
- Two support positions were combined into a single position within the Police Department to reduce salary and benefit costs.



• Public Works in-house staff continues to mow Glen Lily and Butler County landfills resulting in a net savings to the City.

- New PC desktops were installed for all employees with more memory, processor power, disk space, and software was updated to the latest Windows and Office suite products.
- Citizens are now able to submit complaints or requests directly via the City's website, automatically creating a work order in our system to assist with efficiency and allow for citizens to check the status of their complaint.


- Bowling Green Police Department adopted a new software management system for tracking and recording property and evidence in the control of BGPD.
- Fire Fleet mechanic duties were transferred to Public Works Fleet Division.



BETTER SECURITY

- Implemented Kaspersky anti-virus software which has resulted in a significant reduction in helpdesk tickets related to viruses.
- Completed installation of security cameras at the Public Works Fleet Division.
- Added physical security access and cameras to the Fire Department Headquarters Building and the Greenwood Fire Station.
- Worked with the Internal Auditor and a consultant to conduct an Information Technology (IT) audit primarily focused on server and network security and financial system security.
- Security initiatives have begun at City Hall Campus as well as Parks Maintenance.





BETTER PRICE TAG

 Worked with Bowling Green Area Convention & Visitors Bureau on litigation of delinquent Transient Room Taxes, with a payment schedule established for \$109,000 including late fees.



- Saved almost \$15,000 by ordering 1,600 tons of deicer during the off season to restock our supply.
- Over \$48,000 was collected from the sale of City surplus property through local and on-line auctions.



- In-house Facilities Management savings from the Public Works Department totals approximately \$100,000.
- Auditing of various occupational license tax returns resulted in approximately \$80,000 in additional revenues.
- Business License inspections resulted in approximately \$262,000 in additional fees for registration and transient fees, net profit license fees and withholding taxes.


- Prepared, submitted and distributed the first City Popular Annual Financial Report (PAFR) to the public.
- The Neighborhood and Community Services (NCS) Housing Division received the High Performer Status from Housing and Urban Development (HUD) for the 8th consecutive year.
- Parks and Recreation was named the 2011Outstanding Recreation Department (large departments) by Kentucky Recreation and Parks Society.



• The Bowling Green/Warren County Drug Task Force received the Drug Task Force of the Year Award from the Appalachia High Intensity Drug Trafficking Alliance (HIDTA).

FISCAL YEAR 2013 KEY BUDGET RECOMMENDATIONS

- The overall City operating budget increased by just under 3% for FY2013 compared to last year's adopted budget.
- The General Fund expenditure budget only increased by just over \$600,000, which is about 1% compared to the previous year.
- No local tax increases were recommended or adopted in the budget.



- The General Fund minimum reserve balance (savings) stands at 20% of revenues to better underwrite the City's financial obligations.
- The City's latest capital road improvement projects include Smallhouse/Cave Mill Road realignment and Hennessey Way realignment. The City will partner with other public and private investors to complete both projects.



- There are no new financed projects proposed in FY2013. The total adopted Capital Improvement Program, including debt, is approximately \$18.6 million.
- \$950,000 in State funds will be used to maintain streets and sidewalks as part of the City's annual overlay and reconstruction program.



- \$1,030,000 in local tax revenues will be used to continue the Stormwater Mitigation Program, including the installation of a stormwater quality treatment system for Whiskey Run, and the Sidewalk Improvement Program for the enrichment of our community livability.
- Over \$1 million will be spent on public safety capital improvement projects to replace vehicles and equipment for the Police Department and to advance software technology in both Police and Fire departments.



- \$646,000 will be invested in the City's Parks and Recreation Department for equipment replacement and facilities improvements, including the construction of a new picnic shelter with restrooms at H. P. Thomas Park and renovations to the showers and locker rooms at the F.O. Moxley Community Center.
- Approximately \$115,000 will be invested in capital improvement projects at the Sloan Convention Center.




