2013: The Year in Review and a Look Ahead

ROADS AND TRANSPORTATION: BETTER WAYS TO GET AROUND TOWN

- Signal improvements, which included installation of standard mast arm and new pedestrian signals, were made at Center Street and 11th Avenue, Chestnut Street and 10th Avenue, and Center Street and Main Street.
- Street cut standards and quality control measures were improved through amendments to Chapter 21 of the City's Code of Ordinances.
- The Smallhouse Road and Cave Mill Road realignment project was completed with collaboration from the City, Warren County and a private developer.



- Portions of curb and gutter on Nutwood Street and East 11th Avenue were reconstructed to correct drainage concerns and accessibility issues.

- Various streets throughout the City were re-paved in order to repair damaged roads and provide safer transportation routes.
- Funding was provided to support the operation of the GO bg Transit System.

STRONG NEIGHBORHOODS: IMPROVING INFRASTRUCTURE, EMPOWERING PEOPLE

- A new neighborhood association website was designed and is accessible at <http://www.bgcan.org/>.



- The Loop Street Sinkhole was graded, helping to eliminate stormwater issues in the area.
- A 2.25 acre drainage basin was constructed on Covington Street to assist the neighborhood with flooding from the Batsel Sinkhole.
- A partnership with Habitat for Humanity for volunteer coordination of the Code Offense Volunteer Eligible Repair (COVER) Program assisted three households in the repair of exterior code deficiencies.
- A force main was installed in the Audubon Drive/Glen Lily Road area in order to alleviate stormwater issues by pumping water into a drainage basin adjacent to Carla Drive.

- Sidewalk construction was completed on Russellville Road, East 11th Avenue, Holly Drive, Collett Lane and Steeplechase Way, providing safer and more walkable neighborhoods.



DOWNTOWN REDEVELOPMENT/RIVERFRONT

- Monitoring of the City's involvement and contingent liability associated with the Block 6 Wrap Development in the Downtown Tax Increment Financing (TIF) District continued.
- The Finance Department completed the 2011 TIF revenue calculation (4th year) and distributed 80% of the incremental revenues to the Warren County Downtown Economic Development Authority, Inc.
- The exterior of the City Hall Annex building was painted in order to improve the overall appearance of the property.

PUBLIC SAFETY: MORE STAFF, BETTER EQUIPMENT

- Implementation of a new in-car camera/video system was completed for multiple cars in the Police Department.



- New "Hot Sticks" which help identify electrically charged structures with compromised electrical grounds were installed on all fire apparatus.
- A new bar-code tracking system for evidence at the Police Department was developed and implemented.
- An aircraft rescue and firefighting apparatus was added to provide backup response to incidents involving aircraft crashes, allowing the BGFD to respond from two directions.
- The Public Safety Voice Radio Communication System approved by the City and Warren County will provide more coverage as well as a back-up system once installed.
- The 911 Communication Center Computer Aided Dispatch (CAD) software and Records Management software were upgraded and an agreement was developed to share limited access with Warren County and WKU.
- A new waterline was installed at the Police Department firing range in order to provide access to water while conducting training.

- A detective was assigned to Digital Forensics full-time in order to manage the increasing workload as the demand for digital analysis of evidence rises.



PARKS AND RECREATION: NEW AND IMPROVED FACILITIES

- Parks Maintenance poured 500 yards of concrete to improve facilities including a stamped sidewalk at the Hobson House.
- 55 City-owned garden plots were leased out in 15 minutes at Kereiakes Park.
- The Parker-Bennett Community Center playground, sidewalks and shelter were reconstructed with in-house labor and Community Development Block Grant (CDBG) funds.



- 550 participants attended youth golf clinics and camps held for ages five to 15.
- A new lighting system was installed at the Kereiakes Park basketball court as well as nearby tennis courts.

- Dugouts and score boxes were re-constructed at Lampkin Park Fields #1 and #2.



- The locker rooms at Bowling Green Parks and Recreation Fitness facility were renovated using in-house labor.
- An ADA wheelchair lift was purchased and installed at the Russell Sims Aquatic Center.
- The Park Ranger Program was reinstituted, providing better security and maintenance of City parks.
- Construction on additional restrooms began at the Lovers Lane Soccer Complex.
- The City's Golf Program was reorganized with a deficit-reduction plan and proposed elimination of the enterprise fund accounting starting in FY15.



WAYS WE'RE SAVING MONEY

- Copiers were replaced with scan to e-mail functions, eliminating a number of printers and fax machines, saving time and money.

- The existing Storage Area Network (SAN) System was replaced with a new system that will cost considerably less to support.
- Procurement card transactions increased by 58.5%, which improves efficiencies in invoice processing and payments while also providing cost savings.
- \$4.2 million of the 2002A and remaining 2004A G.O. Bonds were refinanced, which will save the City over \$300,000 during the next 6 years.
- Exterior and interior lights were upgraded to LED at multiple City buildings with in-house labor, resulting in approximately \$6,000 in savings.
- The City was recertified as a "Drug-Free Workplace" through the Department of Workers' Claims, which provides the City with a 5% worker's compensation premium savings of approximately \$21,000.



- The pool of potential bidders for City projects was increased by 6.2% to ensure competition and to achieve the best price and value for purchases greater than \$20,000.

BETTER WAYS OF WORKING

- A new internally supported Voice Over Internet Protocol (VOIP) phone system with new features and reduced cost was implemented.

- The storage capacity for surplus materials and equipment was significantly increased through better organization of available space and more frequent turnover/disposal methods.



- A new texting system was launched to communicate information to residents regarding golf, general information, neighborhood news and general information in Spanish.
- Contractors and others can now view the current status and processing of online permit requests with the new ePermit system.
- A Language Access Plan and Taskforce were developed in order to better serve new English language learners in the City.
- A new web based Geographic Information System (GIS) interface was developed allowing for easier migration through layers of GIS information on the City's website.
- The BGFD upgraded the loss control program with a commercial wet vac system that can save customers thousands of dollars associated with water damage on an emergency scene.
- Changes in the Purchasing Office were implemented to increase efficiencies and policy compliance, including the development of new procurement related forms and training materials.

- A 120 day pilot study of the DriveCam product began to evaluate driver events by recording data surrounding accidents or other incidents.

BETTER SECURITY

- Additional security cameras were installed at several City facilities to enhance the existing security network of cameras.



- A bid accepted for City Hall Campus upgrades will provide restricted access areas and key pad security options.
- A new security system was installed at the Fleet Management facility.
- The BGFD re-implemented the "Safe Spot" Program which allows for a safe and secure spot to leave abandoned infants.





- Over \$16,000 was collected from three on-line public auctions of surplus and confiscated items through GovDeals.com.



- Staff recovered over \$13,000 in City property losses through outside insurance agencies, City insurers and recovery from individuals through personal payments or court-ordered payments.
- Staff worked with the Bowling Green Area Convention and Visitors Bureau on litigation of delinquent transient room taxes resulting in additional revenues totaling \$109,000 including late fees.
- A grant for more than \$70,000 was awarded for thermal imagers for the BGFD to improve the ability to see in a smoke filled atmosphere.
- A rebate of approximately \$7,500 from TVA is expected for multiple LED upgrades throughout the City.
- A reduced janitorial contract was renewed for three years, which will continue to save the City \$32,000 annually.
- A change in life insurance carriers saved the City approximately \$2,700 during the fiscal year with no overall cost increase to employees.

- A follow-up with Kentucky Emergency Management and FEMA regarding a previous denial of funding related to the 2010 flooding resulted in the receipt of an additional \$10,000.

DISTINCTIVE

- Participation in ICMA's Center for Performance Measurement Data Reporting and Comparison Program continued for the sixth year.

- The City organized and hosted the nationally televised American Idol auditions at Fountain Square Park with over 1,000 participants.



- The City's FY13 Budget Document received the Distinguished Budget Presentation Award from the Government Finance Officers Association (GFOA).

- The BGFD collected \$20,000 for the Muscular Dystrophy Association through the "Fill the Boot" campaign.

- The Housing Division of the Neighborhood and Community Services Department received the High Performer Status from Housing and Urban Development for the ninth consecutive year.
- A balanced operating budget for Fiscal Year 13/14 was prepared and presented two weeks ahead of the traditional budget planning/preparation schedule.
- A new City television program called BG Mythbusters was created to discredit misinformation about City services or procedures.




OUTSTANDING

- Received the GFOA Certificate of Excellence in Financial Reporting for the FY12 Comprehensive Annual Financial Report (CAFR).
- Received the GFOA award for Outstanding Achievement in Popular Annual Financial Reporting (PAFR).
- The Fleet Division worked 2,371 days without a lost time accident.
- 26 participants attended the first "Over 50" Citizen's Academy.
- The BGFD partnered with Toys for Tots and delivered toys to 400 kids on Christmas morning.



- The BGPD was re-accredited for the fifth consecutive 5-year term.
- “I Speak Cards” were developed to assist speakers of 13 different languages in accessing City services.



FISCAL YEAR (FY) 2014 KEY BUDGET RECOMMENDATIONS

- Compared to last year's adopted budget, FY14 revenues are projected to increase by 3.2% for All Funds and 2.3% for General Fund.
- The City's overall expenditure budget has increased by 4.3% for FY14, with the General Fund expenditure budget only increasing by \$750,000 (1.4%) compared to the previous year.
- Excluding Capital Improvement Projects, the FY14 All Funds Operating Budget has decreased by \$353,535 (0.4%) and the General Fund Operating Budget has increased by \$385,000 (0.7%) compared to the FY13 Adopted Operating Budget.
- No local tax increases were recommended or adopted in the budget.
- The General Fund minimum reserve balance (savings) remains at 20% of revenues to better underwrite the City's financial obligations.

- The total adopted Capital Improvement Program, including debt, is approximately \$22.3 million and includes the financing of only a portion of the county-wide radio system replacement. The City is using previously saved money for several of the larger Capital Improvement Projects included in the FY14 budget.



- \$1.2 million in state funds will be used to maintain streets and sidewalks as part of the City's annual overlay and reconstruction program and to continue the upgrade of traffic signals and intersection improvements in the downtown area.
- \$950,000 in local tax revenues will be used to continue the Stormwater Mitigation Program, the Sidewalk Improvement Program and to make improvements to the remaining three-block area of Heritage Trail for the enrichment of community livability.

- Over \$3.4 million will be used to enhance technology, with the largest single project being the replacement of the public safety 800 MHz Radio System (\$3.3 million for the City's share of the cost).
- Nearly \$663,000 will be spent on Capital Improvement Projects to replace vehicles and equipment for various departments.
- Approximately \$2.8 million will be invested in several City facilities to perform necessary repairs and renovations to increase energy efficiencies, reduce waste, enhance safety and security, address storage needs and to better serve customers. Of the total investment, \$1.5 million will come from previously set aside savings, federal and state revenues, and enterprise generated revenues.
