ORDINANCE RELATING TO BUDGET AMENDMENT

ORDINANCE APPROVING AMENDMENT
NUMBER FIVE TO THE CITY OF BOWLING
GREEN, KENTUCKY ANNUAL OPERATING
BUDGET FOR FISCAL YEAR 2020

WHEREAS, KRS 91A provides that the City Legislative Body may amend its Budget Ordinance at any time after adoption of said Ordinance; and,

WHEREAS, the Board of Commissioners of the City of Bowling Green, Kentucky adopted its Budget Ordinance for Fiscal Year 2020 on June 18, 2019 by Ordinance No. BG2019-25 and approved Amendment No. One on November 5, 2019 by Ordinance No. BG2019-46, Amendment No. Two on February 18, 2020 by Ordinance No. BG2020-2, Amendment No. Three on June 2, 2020 by Ordinance No. BG2020-8 and Amendment No. Four on July 16, 2020 by Ordinance No. BG2020-16; and,

WHEREAS, the City of Bowling Green, Kentucky now desires to approve Amendment Number Five to its Fiscal Year 2020 Annual Operating Budget to provide for changes in various funds as explained in the attached memorandum and as set forth in Exhibit No. 1.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky as follows:

1. The Annual Operating Budget for Fiscal Year 2020 is hereby amended in the amounts as explained in the attached memorandum and as set forth in Exhibit No. 1 attached hereto.
2. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall for any reason be declared invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.
3. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict herewith are hereby repealed.

4. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on

July 21, 2020, and given final reading on August 4, 2020,
